Accommodation

Two minutes away from the educational buildings, the UIR residential complex is a real place for exchanges, sharing and encounters. All the necessary prerequisites for the student's personal and student fulfilment are met. The university residence halls at UIR provide a modern housing offering that meets all current standards. The university residence halls at UIR have double and single room options with free Wi-Fi, study, and relaxation lounges, 24-hour security service, etc. The university residence halls at UIR are not co-ed: Some residence halls are reserved for female students and others for male students.

Green spaces have also been set up around the university residence halls to provide all the conditions for the well-being of students. It is essential to respect these areas and to ensure that everyone can rest and work in the best conditions. The access times to the university campus are from 6am to midnight and the visiting times from 8am to 8pm.

Exchange students may apply for accommodation in a students' residence hall. In general, there is, unfortunately, a major shortage of rooms. That is why only part of the students can be accommodated in dorms. We recommend applying as early as possible for a room. As far as private accommodation is concerned students should also take into consideration to not only stay in the city center but also in the near surroundings.

QTEM calendar (TBC)

For students outcoming in the Fall semester

- November 15th: Deadline to submit application.
- December 15th: Interviews of QTEM applicants performed.
- December 31st: QTEM pre-selected candidates are announced.
- January 30th: Deadline to submit GMAT/GRE test score.
- **February 20th: Final list of QTEM candidates is confirmed.**
- March 31st: QTEM students must communicate their preferences for exchange.
- September of the next year: The QTEM exchange begins.

For student outcoming in the Spring semester

- March 15th: Deadline to submit application.
- April 15th: Interviews of QTEM applicants performed.
- April 30th: QTEM pre-selected candidates are announced.
- May 30th: Deadline to submit GMAT/GRE test score.
- **June 20th: Final list of QTEM candidates is confirmed.**
- July 31st: QTEM students must communicate their preferences for exchange.
- January of the next year: The QTEM exchange begins.



Overall selection criteria

- **Academic excellence**
Excellence is assessed through the GPA and the grades of the quantitative courses.
- **English proficiency**
The student must have a valid TOEFL or TOEIC or IELTS, or any internationally recognized English certification.
- **Quantitative proficiency**
The student must have advanced knowledge on Business Statistics and Multivariate analytics.
- **International experience**
International experience on prior exchange programs or internships would be a plus.
- **Professional / extra-academic experience**
Students should have performed internships in companies.
It is appreciated if the student took part in extracurricular and social activities.
- **GMAT**
GMAT is a compulsory entry pre-requirement: ≥ 650 student meets the common acceptance pre-requisite for QTEM 600
